

## RELEASE AND INDEMNIFICATION AGREEMENT

I understand that the use, discharge, transportation & storage of all firearms, ammunition & explosives are each inherently dangerous & can cause serious & grievous injury and/or death. I have, therefore, obtained & possess all licenses, permits, & permissions required by law; possess & utilize all safety equipment and implements needed to render them, their transportation, storage & use safe and lawful in all respects and undertaken and observe all training & safety instructions as necessary to watch and participate in all activities, events & competitions involving the use, display, discharge or storage of any firearm without harm to myself or others.

I have provided all of the firearms, ammunition, equipment, customs, clothing, carts, animals and mechanical & human powered vehicles, & all other items ("Stuff") which I employ and intend to use or display in any cowboy reenactment, activity, competition or game ("Cowboy Outing") held under the auspices of the Long Riders and/or the Vile Bunch.

Neither the Long Riders nor the Vile Bunch have selected, provided, examined, tested, sold, leased or loaned any of the Stuff used by me other than the targets and props employed by all the participants in the Cowboy events. Neither has prepared or inspected nor made any representations to me as to the safety, utility, or appropriateness of the location at which any Cowboy Outing is to be conducted. I have carefully examined all of the above and have assured myself of the condition, safety and utility of each & have received no representation or warranty concerning any of the foregoing except that the Shortsville Rod and Gun Club has acknowledged that its premises are a lawful location at which a firearm may be discharged safely under their rules.

To participate in Cowboy outings, it is vital that each of us conduct ourselves, always, in a safe manner & in compliance with all rules and regulations. I agree, therefore, to conduct myself, at all times, appropriately, in a safe and healthy manner, to promote all actions which will enhance my own safety and that of others, to promptly adhere to all instructions given by all safety officers, & to adhere to all applicable rules, and laws of the Shortsville Rod and Gun Club, SASS, the Long Riders, the NRA, New York State, and the United States.

I agree to defend indemnify, save and hold harmless the Long Riders, the Vile Bunch, Shortsville Rod and Gun Club and each participant in & observer of each Cowboy outing from any & all damages, harms, personal and property damage & injury caused in whole or in part by me.
